Terms of Contract

The terms of consignment are 55% of the final sales price to the owner and 45% of the final sales price to the store. Items will be discounted 10% each month for the first 4 months unless otherwise agreed upon between consignor and management.

Upon consigning, owners must decide whether cosigned items will be picked-up by consignor, forfeited to store, or donated to Habitat Home Store or a similar entity, should the item not sell. Donated items will be valued and donated in the owner's name. Habitat Home Store will mail the tax forms directly to the consignor.

When consignor is contacted by phone for pick up and items are not picked up within 7 business days items are considered abandoned and become the property of Wallpaper & Designer Home.

It is **NOT** possible to insure consigned items for theft or fire. Should such an event occur, owners must claim any loss on their homeowner's insurance. I, the undersigned, agree to hold harmless and make no claim against Wallpaper & Designer Home Consignments, its owners, employees, lessees and/or owners of the space where the sale is held, any volunteer and/or paid participants in Wallpaper & Designer Home Consignments, for the damage, theft, or loss of any items consigned to Wallpaper & Designer Home Consignments. Wallpaper & Designer Home Consignments does not anticipate any thefts, damage, or loss and takes every precaution to prevent them; however, these events may occur and the consignor assumes the risks of these events by participating as a consignor.

I agree to not use any knowledge I have learned from being a consignor with Wallpaper & Designer Home Consignments Consignment to open up a competing consignment sale within a 30 mile radius of a Wallpaper & Designer Home Consignments Sale.

I agree to waive any and all claims for personal injury resulting from participation in Wallpaper & Designer Home Consignments Consignment Sale from whatever cause either foreseen or unforeseen against Wallpaper & Designer Home

Consignments, its owners, the lessees and/or owners of the space where the sale is held, and/ or any volunteer or paid participants in Wallpaper & Designer Home Consignments Sale.

I have checked all my items for recalls and each item complies with applicable law, and no item is the subject of any pending or threatened recall notice or other consumer protection enforcement action. I know of no reason why any item offered for sale would cause injury to another.

I agree that all seasonal items may be marked with "Reduce" on the printed tag will be offered for sale at 50% off the listed price during the discount sale days.

Consignor Checks are mailed the 10th of each month following the sale of items. Wallpaper & Designer Home Consignment is not responsible for lost or misplaced checks. Please cash your check within a 60 day period. If you do not cash your checks prior to 60 days from the date on the check(s) they will be considered abandoned, the check(s) will be canceled/voided, and the monies will be property of Wallpaper & Designer Home.
